The following stumpage appraisal parameter values are effective July 1, 2000.

Coast Composite Index	246.4
Coast Target Rate	23.19
Coast Mean Value Index	-3.63
Coast Base Rate	24.00

The average market values of logs, district value indexes and district average basic silviculture costs (for use with the district value indexes) also effective July 1, 2000, for use in the Comparative Value Pricing System, are attached.

For the Market Pricing System, the consumer price index and coastal log prices for stumpage rates calculated from July 1, 2000 to July 31, 2000, and the consumer price indexes and log prices for the previous two months are also attached. 
