


MINISTERIAL ORDER
(section 170 (2) *Forest Act*)
Central Coast Designated Area

I, Rich Coleman, Minister of Forests and Range and Minister Responsible for Housing, order the following with respect to the Central Coast Designated Area, which was established as a designated area by B.C. Reg. 82/2006:

1. all plans, prescriptions, licences, cutting permits, timber sale licences, and road permits within the designated area are suspended, except those exempted from this order as listed in Schedule A;
2. any person authorized to issue a cutting permit road permit or timber sale licence, or to approve an operational plan is directed not to do so, if any part of the permit, licence or plan within the designated area, except for those permits, licences or plans exempted from this order as listed in Schedule A.
