

Vehicle access is restricted on the following Gated Roads (Alphabetical Listing by Geographic Area). Closures or restrictions may be fulltime, seasonal or during active industrial (eg. Logging, blasting, mining) operations

Primary reasons for restrictions include: safety risks to the public, extreme or high fire hazard and environmental protection. Secondary reasons include protection from environmental impacts the areas sustain from the dumping of garbage, both domestic and industrial, the demolition and burning of stolen and abandoned automobiles and vandalism.

Access restrictions are not to stop the public or organizations from using the area but rather one of controlling access. In some cases, Users may be able to gain access by registering and obtaining a key for the locked gate from the following contacts. Certain restrictions including Identification and a registration fee may apply.
