



## RESTRICTION ORDER AMENDMENT Number 2

(section 84 of the *Forest Practices Code of British Columbia Act*)

The undersigned designated forest official hereby orders that, effective 12:01 am on September 12, 2003, section 1 of the order made by me on August 28, 2003, that is attached as Schedule A, and that was amended by Restriction Order Amendment Number 1, that is attached as Schedule B, is further amended by repealing paragraph (b).

# RESTRICTION ORDER

(section 84 of the *Forest Practices Code of British Columbia Act*)

1. The undersigned, designated forest official considers it appropriate for the reasons specified in section 84 (1) (a), (b) and (c) of the *Forest Practices Code of British Columbia Act*, that this order be made, and hereby orders that, effective from noon on August 29, 2003 and until the earlier of September 14, 2003 or the date this Order is rescinded, the Crown lands within the following forest districts are restricted areas:
  - (a) South Island forest district;
  - (b) Chilliwack forest district;
  - (c) Squamish forest district;
  - (d) Columbia forest district;
  - (e) Arrow Boundary forest district;
  - (f) Kootenay Lake forest district;
  - (g) Rocky Mountain forest district;
  - (h) Kamloops forest district;
  - (i) Okanagan Shuswap forest district;
  - (j) Cascades forest district;
  - (k) that part of the Headwaters forest district that is south of the community of Blue River.
  
2. The areas referred to in section 1 do not include
  - (a) areas covered by water, or
  - (b) areas in Provincial Parks that are
    - (i) supervised, developed campgrounds, or
    - (ii) day use areas accessible by road.

3. This order does not prevent a person from
- (a) travelling to and from or occupying his or her residence,
  - (b) using a highway, as defined in the *Highway Act*, or
  - (c) carrying on or travelling to and from
    - (i) a livestock management operation that relates to a licence or permit entered into under the *Range Act*, or
    - (ii) an infrastructure maintenance operation, including but not limited to, utilities, telecommunications, pipelines and water storage,
- that does not use a chain saw, an all terrain vehicle, a motor cycle or another tool or vehicle if that other tool or vehicle is powered with a small engine as defined in the Forest Fire Prevention and Suppression Regulation.


