## INSTRUCTIONS

1. Indicate whether you want to borrow or buy an item (e.g., a book).
2. Indicate the date ordered.
3. Indicate the title of the book or the journal article. If there is a series number (e.g., USDA Forest Services Research Note RM 32), indicate it here.
4. Indicate the author of the item.
5. Indicate the journal name or, if you are purchasing, the book publisher (it is not necessary to fill out the publisher if you are only borrowing the item).
6. a) for a journal article, indicate the volume, issue, pages and year (e.g., 12 (1) 322-342 1983);  
b) for a book request, borrow or purchase, indicate the year.
7. Indicate your name and location.
8. If you are purchasing a book or journal subscription, indicate your Vote, Activity, Responsibility Centre and STOB number. Have the form signed by the appropriate Signing Authority. If you don't know what your coding is or who your Signing Authorities are, ask your Office Manager.
9. If you channel your requests through your Regional Ministry of Forests library, indicate it under "c/o Regional Library" (e.g., PG or NE or PR). Make sure your library is still operating before you send your request.
10. Use the "Notes" field for special instructions (e.g., "my deadline is X" or, if you know the call number, "634.909711 B324", or "I know this is at U. B.C.").
